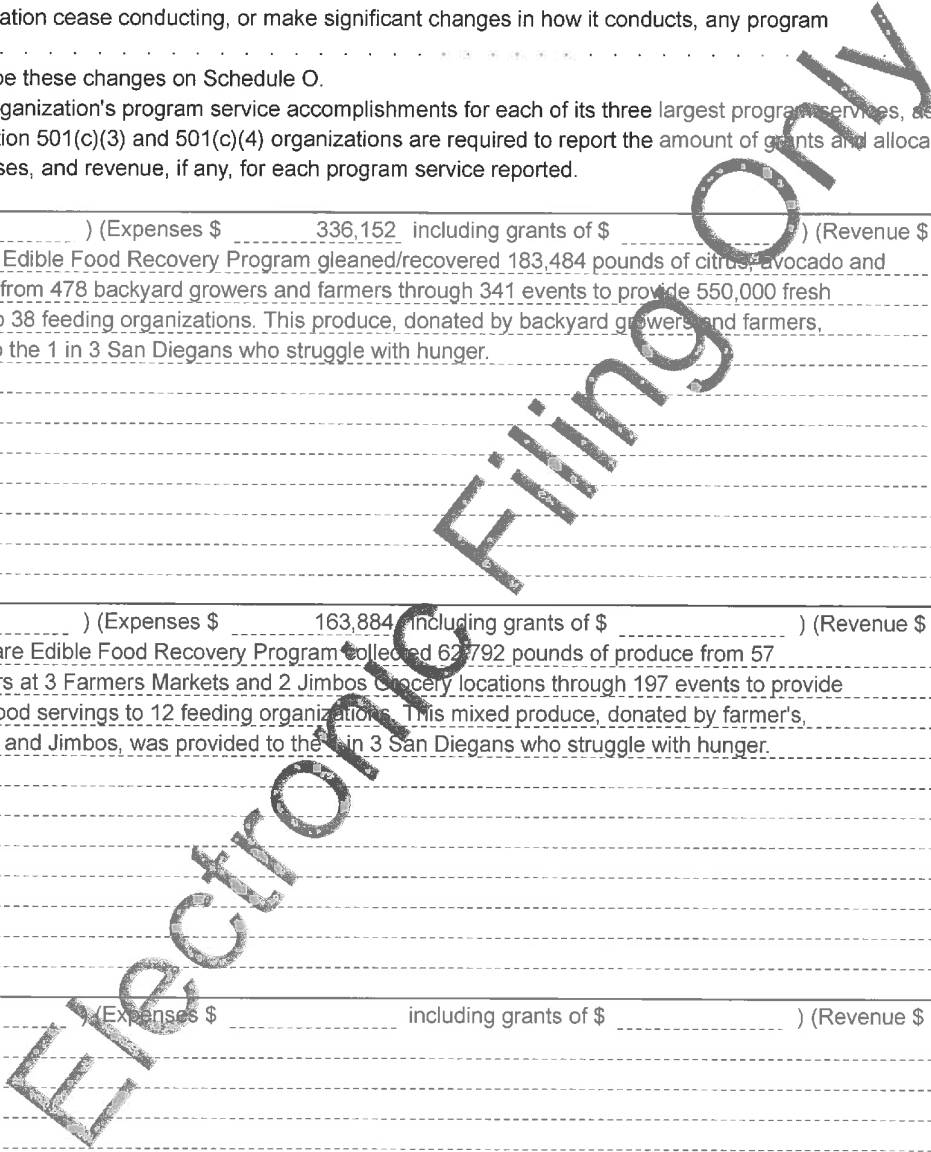
4a (Code:) (Expenses \$ 336,152 including grants of \$) (Revenue \$ 112,174) The CropSwap Edible Food Recovery Program gleaned/recovered 183,484 pounds of citrus, avocado and mixed produce from 478 backyard growers and farmers through 341 events to provide 550,000 fresh food servings to 38 feeding organizations. This produce, donated by backyard growers and farmers, was provided to the 1 in 3 San Diegans who struggle with hunger.

4b (Code:) (Expenses \$ 163,884 including grants of \$) (Revenue \$ 65,880) The Market Share Edible Food Recovery Program collected 62,792 pounds of produce from 57 Farmers/Grocers at 3 Farmers Markets and 2 Jimbos Grocery locations through 197 events to provide 188,376 fresh food servings to 12 feeding organizations. This mixed produce, donated by farmer's market vendors and Jimbos, was provided to the 1 in 3 San Diegans who struggle with hunger.
