The CropSwap Edible Food Recovery Program gleaned/recovered 222,514 pounds of citrus, avocado and mixed produce from backyard growers and farmers through events to provide 667,542 fresh food servings to feeding organizations. This produce, donated by backyard growers and farmers, was provided to the 1 in 3 San Diegans who struggle with hunger.

The Market Share Edible Food Recovery Program collected 93,762 pounds of produce from Farmers/Grocers at Farmers Markets and Jimbos Grocery locations through events to provide 281,286 fresh food servings to feeding organizations. This mixed produce, donated by farmer's, market vendors and Jimbos, was provided to the 1 in 3 San Diegans who struggle with hunger.
